Abstract Submission Guide

The abstract should be prepared according to the guidelines provided below and uploaded to the CMT portal for IRCUWU2025, along with the **extended abstract**.

#### 1. Abstract

The abstract must not exceed 350 words prepared in a single B5 page using **MS Word**, .docx, or .doc format without author names and affiliations. Use the <u>abstract template</u> or the guidelines at the end of this document to prepare your abstract for initial review. https://irc.uwu.ac.lk/wp-content/uploads/2025/07/abstract-template.docx

# 2. Extended Abstract (Compulsory)

An Extended Abstract prepared according to the given format/guidelines are required to be uploaded in PDF for review purposes. However, as recommended by the reviewers, the authors will get an opportunity to publish their extended abstracts in upcoming UWU Research Journals. (i.e., Journal of Management and Tourism Research or Journal of Technology and Value Addition or Journal of Agriculture and Value Addition, Journal of Science and Technology, etc.). The organizing committee will contact the corresponding authors separately about publishing extended abstracts in UWU journals.

# **After Accepting your Abstract**

Once the abstract is accepted, authors must submit the **Camera-Ready Copy of the abstract** (not the extended abstract) using the Camera-Ready Template (<a href="http://irc.uwu.ac.lk/wp-content/uploads/2025/10/camera-ready-template.docx">http://irc.uwu.ac.lk/wp-content/uploads/2025/10/camera-ready-template.docx</a>).

The submission must include:

- 1. The Camera-Ready Copy in MS Word (.docx or .doc) format
- 2. A scanned copy of the **Author Declaration Form** (<a href="https://irc.uwu.ac.lk/wpcontent/uploads/2025/07/author-declaration-form.docx">https://irc.uwu.ac.lk/wpcontent/uploads/2025/07/author-declaration-form.docx</a>), signed by all authors
- 3. A copy of the **registration fee payment slip** (online or physical)
- → Note: The proceedings compilation team requires the MS Word documents to make corrections if necessary.

Publication in the conference proceedings will only proceed once all required documents are submitted and complete.

#### GENERAL GUIDELINES

- Authors are allowed to submit their work for either Oral Presentation or Poster Presentation. Oral presentations will be held both online and physical mode and poster presentations will be held in online mode in parallel sessions categorized under 14 thematic areas.
- Authors should upload abstracts to the <u>CMT system</u> leaving out the names of authors and their affiliations for the purpose of reviewing. However, author details must separately be added to the appropriate section of the CMT submission page.
- Abstracts bearing author details will be rejected.
- Authors should ensure to leave sufficient space in the Abstract to add author details (names and affiliations) after reviewing for final submission.
- Authors should add author details after the abstract is accepted for publication (Camera Ready Copy).
- Research work presented or published elsewhere will not be considered.
- Abstracts will be rejected without further consideration if plagiarism is detected.
- The Editorial Committee recommends that all authors verify their abstracts against plagiarism using a free online plagiarism checker before submission (e.g. <a href="http://www.plagscan.com/seesources/analyse.php">http://www.plagscan.com/seesources/analyse.php</a>).
- Authors should submit abstracts under one of the 14 thematic areas. However, the Editorial Committee reserves the right to assign the abstract to the most relevant thematic area if necessary.
- Authors should submit the extended abstract to the CMT system separately (compulsory). In addition to using extended abstracts in the reviewing process, the selected ones will be considered for publishing in either Journal of Management and Tourism Research, or Journal of Agriculture and Value Addition, or the Journal of Science and Technology. The extended abstract template and preparation guidelines can be downloaded as a separate file. It should not exceed five pages, including references.
- Abstracts submitted without an extended abstract will not be considered for review.
- Upon acceptance of the abstract, authors must upload a scanned **Author Declaration Form** signed by all authors, along with the **Camera Ready Copy** to the CMT system.
- Publication in the proceedings will only proceed once all required documents are complete.

Please use formatting as mentioned in <u>Abstract Template</u> or follow the specific guidelines given below for Abstract preparation.

#### **GUIDELINES FOR THE ABSTRACT**

All abstracts should be written in English language using MS Word (.docx/.doc format).

#### **Limit of the Abstract**

Abstract must not exceed one B5 sheet (350 words) within the given format. Please do not change your page layout. Directly copy into the **Camera-Ready** Format for final submission.

The abstract should contain the following.

#### Title of the Abstract

Font : Times New Roman

Font Size : 12 pt Style : **Bold** 

Title should be concise, specific and reflective of the study carried out. It should be centeraligned with the first letter of each word, other than the prepositions, capitalized scientific names of organisms should be written in italics. If common or vernacular names follow the scientific name, they should be included in parentheses.

## **Body of the Abstract**

Font : Times New Roman

Font Size : 10 pt

Margins : 1 inch for left, right, top and bottom

Line Spacing : Single Spacing before and after : 0

Spellings : British type
Non-English and Technical Terms : In *italics*Abbreviations : Not allowed
Figures, Tables, Plates : Not allowed
Text : Justified
Page numbering : Not allowed

The abstract should state the problem, explain the approach to obtaining the solution, and describe the solution itself. It should also summarize key facts relating to the work done, the principal conclusions, and it should convey the overall impact of the work presented.

4–6 keywords in **alphabetical order**, separated by a semicolon (;).
